# **HOW DO YOU ACCESS THE PRACTICE EXAM?**


- Your "Authorization to Test" notification will include a link to the Pearson VUE <u>landing page</u>. From there, create your Pearson VUE account.

  - After signing into your Pearson account, your Dashboard will appear.




#### ANSWER AND RATIONALE REVIEW
